THIS INDENTURE, made this 25 day of October A. D. 1932

by and between Walter J. Neely

party of the first part, and the MECHANICS BUILDING AND LOAN ASSOCIATION, of Greenville, S. C., a corporation, party of the second part,

WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of Twenty-four hundred and no/100ths Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum payable weekly, the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County in the State aforesaid, as follows, to-wit:

Being known and designated by the major portion of Lot No. 9 on Arlington Avenue, Sans Souci, as shown on revised Plat of B. E. Neer Property, which plat is recorded in Plat Book "S", page 243, R. M. C. office for Greenville County, and being more particularly described as follows:

Beginning at a stake on Arlington Avenue, West of the intersection of Pine Street and Arlington Avenue, corner of Lot No. 8 in a northerly direction 150 feet; thence in a northerly direction 54 feet; thence in a southerly direction 150 feet to a stake on Arlington Avenue 58 feet from the beginning corner, thence with said Arlington Avenue 58 feet to the beginning corner, being the same conveyed to me by W. H. Wright by deed dated March 19, 1932, and recorded in Deed Book 1610, page 436, R. M. C. office for Greenville County.

Waiver
