WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of Thirty Seven Hundred and No/100ths Dollars,

money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly, the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part, all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

On the West side of East North Street in the city of Greenville, lying between and designated as Lot No. 1 of the George Howard Subdivision as shown on plat made by W. M. H. A. S., Engineer May 1929, and having the following lines and bounds: Beginning at an iron pin on the east side of East North Street, corner of Lots 1 and 2, as shown on said plat, and running thence with the joint line of said Lots 1, 4 & 2 E. 200 feet to an iron pin; thence N. 41-04 E. 45.9 feet to an iron pin; thence N. 48-56 W. 200 feet to an iron pin on eastern side of East North Street; thence with East North Street as now located S. 41-02 W. 54 feet to the beginning corner, being the same lot of land conveyed to me by the Mechanics Building and Loan Association by deed dated September 17<sup>th</sup>, 1932, recorded in W. M. C. office for Greenville County in Deed Book 116, page 507.

For value received of Anna M. Beatty, the owner and holder of a Mortgage Lot 23 recorded in W. M. C. office for Greenville County in Book 241, page 170, hereby waives the lien of my said Mortgage in favor of the Within Mortgage, so that the Within Mortgage for \$3,700 will constitute a first lien on the Within described premises and the Mortgage for 223 to Anna M.
