Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

That lot of land in the City of Greenville, State of South Carolina, on the east side of Robinsou Street, known and designated as Lot No. 4 of plat made by Dalton & Neves for G. L. Stone, and recorded in Plat Book "A", at page 222, and being part of lot 19, Section "B" of plat of Stone Land Company, plat recorded in Book "A", pages 237-245, and having the following courses and distances: Beginning at a pin on East side of Robinsou Street, a distance of 160.10 feet south of the southeast corner of Pendall and Robinsou Streets and running thence S. 85° 13' E. 108.6 feet to pin; thence S. 141° 26.57 feet to pin, corner of Lot No. 5; thence N. 86° 03' 24.108.6 feet to pin on Robinsou Street, thence with Robinsou Street N. 141° 0.52.76 feet to beginning corner being the same lot conveyed to G.
