WW, KNOW ALL MEN, That first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to be conductive, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of Ord Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell and release in fee simple, unto second party, successors and assigns, the following described lands, to wit:

All that certain piece, parcel, and tract of land lying and being situate in Butler Township, County of Greenville, State of South Carolina, containing Forty-eight and 15/100 (48.15) acres according to a survey and plat made by W. J. Riddle, Surveyor, March 1, 1935, and bounded on the North by lands of I. S. Burrell and J. H. Hamilton; on the East by J. H. Jones and Riley Peace; on the South by Ed. Copeland and C. B. Jones; on the West by Arthur Smith, and descirbed by courses and distances on the Riddle plat as follows, to-wit:
