*J. H. T. Pickelimer*SEND GREETING: *142*Whereas, I, the said *J. H. T. Pickelimer*in and by *May* certain *January*these presents, *February* well and truly indebted to *Wm. H. C. Nathan*in the full and just sum of *Two Hundred Seventy Five Dollars (\$275.00)* *10/100* Dollarsto be paid *one year after date**First and this month*with interest thereon from *date*at the rate of *per cent. per annum, to be computed and paid* *annually*until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *trustee's cost (10%)* besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.NOW KNOW ALL MEN, That I, the said *J. Nathan*according to the terms of said note, and also in consideration of the further sum of Three Dollars, to the said *J. H. T. Pickelimer* in hand well and truly paid by the said *Wm. H. C. Nathan*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

Wm. H. C. Nathan, her heirs and assigns, etc. that I, Captain piece, parcel for lot of land situate, lying and being in Greenville County, Greenville County, South Carolina, outside the corporate limits of the City of Greenville, on Terrell Street near Stock Street & 4th Avenue, standing Road, and being known and designated as Lot No. 11 according to survey made by Walton & Meek, with the following lines and bounds, to wit:

*Begining at an iron pin on Terrell Street and running thence North said Street, S. 87- $\frac{1}{2}$ E. 111- $\frac{1}{2}$ S. 83 feet to an iron pin corner of Lot No. 10; thence North line of Lot 10, N. 36- $\frac{1}{2}$ E. 78 ft. 200 feet to an iron pin corner of Lot No. 1; thence with line of Lot No. 1, N. 52- $\frac{1}{2}$ E. 74- $\frac{1}{2}$ feet to a corner pin on line of *Saturday* property; thence with line of said property, S. 37-49 E. 1.200.1 feet to the beginning corner.*
