in the full and just sum of *Fifteen hundred dollars (\$1500.00)*

to be paid *one year after date set forth* *on* *March* *1930*

with interest thereon from *date of* *set* *for* *one year*

at the rate of *8* per cent. per annum, to be computed and paid

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent*

besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto had, will more fully appear.

is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

Bessie Morris Silversmith, her heirs and assigns,

all that lot of land situate in the State and

county aforesaid, on the West side of North Franklin

Road and designated as Lot No. 239 of Bolania Company

Property, having the following metes and bounds to wit;

Beginning at an iron pin on the West side of

North Franklin Road, joint corners of Lots 239 and 240

and running thence with joint lines of said lots

N. 37-02 W. 200 feet to iron pin, joint corner of Lots

239 and 240; thence S. 32-38 W. 65 feet to iron pin,

corner of Lots 238 and 239; thence with joint line of

last named lots S. 37-02 E. 200 feet to iron pin, joint
