S. F. Simpson, Jr., administrator, his heirs, successors  
and assigns;

All that piece, parcel or lot of land in Greenville  
Township, Greenville County, State of South Carolina, in  
the City of Greenville, on Birne Street, and having the  
following mates and bounds, to wit.  
Beginning at a stake S.  $61\frac{1}{2}$  E.  $57\frac{1}{2}$  feet to a stake  
Ex, thence N.  $26\frac{1}{2}$  W.  $165$  feet to a stake Ex, thence N.  
 $61\frac{1}{2}$  W.  $57\frac{1}{2}$  feet to a stake Ex, thence S.  $26\frac{1}{2}$  W.  $165$   
feet to the beginning corner, and containing  $9087\frac{1}{2}$  feet,
