(1) That tract of land known as a part of the land conveyed to J. H. Green by W. M. Bishop, adjoining lands of J. H. Green, W. M. Bishop, and others; Beginning on a stake on the east side of Buncombe Road, and running thence S 68 E. 19° 33' 58" to an iron pin, thence N 2 1/2 W. 3.50 ch. to a stone m.m., thence N. 71 1/2 W. 19.30 ch. to a stone in Buncombe Road; thence S. 15 3/4 E. 2.50 ch. to the beginning corner, containing 5 acres, more or less, being the same land conveyed to W. Beginning on a stone, thence running N. 08 1/4 E. 17.00 ch. to a stone; thence S. 37 1/4 E. 8.81 chs. to a stone m.m.; thence S. 64 3/4 W. 16.30 ch. to a stone m.m.; thence S. 56.3.4 ch. to a stone m.m.; thence N. 22 1/4 W. 5.10 ch. to beginning corner, containing 2.6 acres, more or less, being same land conveyed to W. M. Bishop by Cain Shelton, by deed dated February 17, 1917, and recorded in Volume 88, page 27, R. M. C. Office for Greenville County.
