with interest thereon from *date of execution of this instrument* at the rate of *7* per cent. per annum, to be computed and paid *Semi-annually* until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *Ten Per Cent* besides all cost and expenses of collection to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto to had, will more fully appear.

The Peoples National Bank of Greenville, S.C., as Trustee for Hartense Risenfeld, the following described property, to wit:

All that certain lot of land situate, lying and being on the West side of Van Noy St. in Ward Two in the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as Lot # B of the F. G. Rogers property as shown on plat recorded in Plat Book "A" at page 421, excepting a small triangle on Van Noy St., but including a triangle of the lot just north of lot # B, which is lot # 6 and being designated as follows;

Beginning at a point on the West side of Van Noy St. at the joint corner of lots A and B as shown on said plat running thence with joint line of said lots A and B 71.80.00 N. 162 feet; thence 71.31.00 E. 51 feet six inches to the rear corner of lot # C; thence N. 84-28 E. 82.3 feet to a point in the center of a garage which point is at the rear end of said garage, which garage is situated entirely on lot # 6; thence straight through the center of said garage S. 58.00 E. 20.2 feet to a point in the center of said garage on the front; thence S. 63.43 E. 68.6 feet to a point on the West side of Van Noy St., which point is 9.7 feet S. of the joint corner of lot # B and # C on Van Noy St.; thence S. 33.29 W. 51 feet; more or less, to the point of beginning, which is the joint corner of lots # A and # B on Van Noy St.
