in and by my certain Promissory Note made note in writing, of even date with
 these presents, am well and truly indebted to Lois Ora Jones
 in the full and just sum of Four Hundred Fifty Dollars (\$450.00)
 to be paid: January 1, 1935.

Principal Due in One Year
 Interest Annually

with interest thereon from date

at the rate of 7 per cent. per annum, to be computed and paid semi-annually
 until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent
 besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto had, will more fully appear.

NOW KNOW ALL MEN, That I, Robert W. Carter,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Lois Ora Jones
 according to the terms and note, and also in consideration of the further sum of Three Dollars, to the said Robert W. Carter,

in hand well and truly paid by the said Lois Ora Jones

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said

Lois Ora Jones,
 All that certain piece, parcel or lot of land, situate lying and being in the City of Greenville, S.C. in Ward two, on the West side of Varnoy Street, and being known and designated as Lot No. "B" and a portion of Lot No. "C" according to the map made by L. S. Rogers, Surveyor, recorded in Plat Book "A", at page 421, R.M.C. Office for Greenville County, and more particularly described according to said plat as follows:-

"Beginning at a point on the West side of Varnoy Street at the joint corners of lots Nos. A & B as shown on said plat, and running thence with the joint line of said lots N. 80-00 W. 162 feet; thence N. 31-00 E. 51 feet 6 inches to the rear joint corner at lot Nos. B & C; then N. 84-28 E. 82-3 feet to a point in the center at the rear end of a garage thence straight through the center of said garage S. 5° 8'-00 E. 20-2 feet to a point at the center in front of shed garage thence S. 63-43 E. 68-6 feet to a point at the West side of Varnoy Street, which said point is 7.7 feet South of the joint front corner of lots Nos. B & C; thence, S. 33-29 W. 151 feet more or less to the point of beginning on Varnoy Street, and being the same lot land heretofore conveyed to the mortgagor herein by Lois Ora Jones and recorded in R.M.C. Office for said Greenville County. This mortgage is a second mortgage over above described property, being junior in rank of lien to the mortgage executed by the mortgagor to the Peoples National Bank, Trustee for H. L. Hausekfeld May 23, 1934 in the sum of \$2000.00 to be recorded in said R.M.C. Office.
