to be paid: *This monthly installment of \$5.00, being decreasing as indicated above, and one the 1st day of each month, paying interest thereon, and so continuing until the principal and interest shall be paid in full.* *Agreements to make and pay monthly out of rents collected from premises or arrears to be covered by this note, and to increase or decrease as aforesaid, and to be made by A. H. Monteith*

with interest thereon from

at the rate of *✓* per cent. per annum, to be computed and paid

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten percent* besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

*All that piece, parcel or lot of land in Greenville
Township, Greenville County, State of South Carolina
on the North side of Arlington Avenue, described as
Lot #1, on the Mc Gee property, and having the
following metes and bounds:*

*Beggingning at a fence post on the
North side of Arlington Avenue, joint corner of
Lots No 1 and 2, and running thence with the
joint line of said lots N. 30° 48' E. 147.5 feet to an
iron pipe in line of the Mc Gee property; thence
with line of said Mc Gee property S. 70° 40' E.
