J. Franklin Williams Jones

SEND GREETING:

Whereas, the said *J. Franklin Williams Jones*in and by *me* certain *day* *month* *year*

note in writing, of even date with

these presents, *me* well and truly indebted to*S. M. Wright*in the full and just sum of *five thousand and one hundred dollars (\$5,000.00)* *to be paid: January first, fifty-one (\$1.00) dollars, interest, plus \$1.50 and two hundred fifty and no/100 (\$325.00) dollars to be paid August first, 1936, with privilege of paying my portion or all of the above amount at any time before maturity, with interest thereon from**date* *at rate* *per cent. per annum,* *to be computed and paid*until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *one dollar (\$1.00)* besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That

I, the said J. Franklin Williams Jones

in consideration of the said debt and sum of money aforesaid, and for the better

securing the payment thereof to the said

S. M. Wright

according to the terms of said note, and also in consideration of the further sum

of Three Dollars, to *the said J. Franklin Williams Jones*

in hand well and truly paid by the said

S. M. Wright

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and these Presents do grant, bargain, sell and release unto the said

S. M. Wright, his heirs and assigns forever;

all that certain piece, parcel or lot of land situated, lying and being in the State of South Carolina, County of Greenville, and in Greenville Townships, in a subdivision known as "Standard," and being described and designated as Lot No. 10 of Block 5, of said subdivision as shown on plat thereof recorded in the S. M. L. office for Greenville County, in said Block 5, page 64, after making according to said grant the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Curzon Street, joint corner of Lots 9 and 10, of Block 5, and running thence south the joint line of said Lots 9 and 10, N. 30° 01' 21. 165 feet to an iron pin, joint rear corner of Lots 23, 24, 9 and 10, thence along the rear line of Lots 10 and 24, N. 63° 30' E. 60 feet to an iron pin, joint rear corner of Lots 24, 23, 10, and 11, thence along the joint line of Lots 10 and 11 S. 26° 51' E. 165 feet to an iron pin on Curzon Street, joint corner Lots 10 and 11, thence along the line of Curzon Street S. 63° 30' 21. 60 feet to the point of beginning.

This mortgage is second and inferior to the lien of the mortgage in the sum of \$2,000 executed by the First Federal Saving and Loan Co. of Greenville, South Carolina.
