AMORTIZATION MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That

*Joseph D. Cooper**Greenville* County and State aforesaid, hereinafter called first party, whether one or more, SEND GREETINGS:

WHEREAS, First party is indebted to the Land Bank Commissioner, acting pursuant to Part 3 of the Act of Congress approved May 12, 1933, known as the Emergency Farm Mortgage Act of 1933, hereinafter called second party, as evidenced by a certain promissory note, of even date herewith, for the principal sum of *Sixteen Hundred and 71/100 (\$1600.00)* Dollars, payable to the order of the second party, together with interest from the date of said note on the principal sum remaining from time to time unpaid, at the rate of *Five (5%)* per centum per annum, the first payment of interest being due and payable on the *15th* day of *November*, 1934, and thereafter interest being due and payable annually; said principal sum being due and payable in *120* equal, successive, annual installments of *One Hundred Sixty and 71/100 (\$160.00)* Dollars each, and a final installment of *(\\$-----)* Dollars, the first installment of said principal being due and payable on the *15th* day of *November*, 1938, and thereafter the remaining installments of principal being due and payable annually until the entire principal sum and interest are paid in full; all of which and such other terms, conditions, and agreements as are contained in the said note, will more fully appear by reference thereto.

of NOW AND ALL MEN, That first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell and release in fee simple, unto second party, his successors and assigns, the following described lands, to wit:

*All that tract or parcel of land containing thirty-six one-fourth (36 1/4) acres in Bates Township of Greenville County, South Carolina, known as the Cooper place, located on the McElhany road, 1/2 mile from Traders Rest, on the waters of Cooper Creek, bounded on the east by lands of G. O. Kinney; on the south by lands of Johnson McRay; on the west by lands of B. F. Goddett; on the north by lands of J. R. Cooper, and having the following courses and distances, according to survey and plat of W. A. Hester, surveyor, October 26, 1933.
Beginning at an iron pin in McElhany Road, running thence with the road south 46 degrees 30 minutes west 12.31 chains to iron pin; thence north 60 degrees 30 minutes west 17.3 chains to stone 40 m; thence north 20 degrees 45 minutes west 28.30 chains to iron pin; thence north 69 degrees 15 minutes east 9.00 chains to iron pin 0 m.; thence north 66 degrees 45 minutes east 4.98 chains to iron pin 0 m.; thence south 16 degrees east 24.65 chains to iron pin in road, Beginning corner.*
