To All Whom These Presents May Concern:

SEND GREETINGS:

WHEREAS, D. L. Beale of Greenville, S.C.

in and by me certain promissory note, in writing, of even date with these presents, one well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, S. C., in the full and just sum of Seven Hundred and Sixty-four (\$700.48) Dollars, and have subscribed to seven shares of the Installment Thrift Stock of said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, S. C., and have agreed to pay therefor at the rate of Fifty (50) Cents per share, per month, until said payments, plus dividends, have reached the par value of One Hundred Dollars per share, at which time said note shall become due and payable, with interest, and

WHEREAS said note provides for the payment of interest on the sum of Seven Hundred and Sixty-four (\$700.48) Dollars, at the rate of Six (6%) per centum per annum, to be computed and paid monthly, in advance, until maturity of said shares of Instalment Thrift Stock in said Association, and I am desirous of securing said debt and interest,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further

sum of Three Dollars to me, the said D. L. Beale, in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, S. C. the following described property, to-wit:

All that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, in Greenville Township, a goodly body of more particularly described, as follows:

Beginning at a stake on Monaghan Avenue, and running back from hundred and six (106) feet, more or less, thence north sixty-six (66) feet, more or less, to a stake on Wimble Street; thence west with Wimble Street two hundred and six (206) feet, more or less; thence south along Monaghan Avenue sixty-six (66) feet, more or less, to the beginning corner, less however, the eastern portion of the aforesaid premises heretofore conveyed by J. S. Wilborn to Duane J. Bargoil by deed dated Oct 23, 1930, and recorded in the R.M.C. Office for Greenville County in Vol 156, page 32, which deed conveys a lot 66 feet on Wimble Street with a depth of 66 feet, beginning 141 feet from the east side of Monaghan Avenue.
