All that certain piece parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Ward One of the City of Greenville, on the east side of Robinson Street, and being known and designated as Lot no 4 on plat made by Dalton & Neves, Engrs. for J. B. Stone, and recorded in the R. M. C. Office for Greenville County in Plat Book G, page 222, and having the following metes and bounds, to-wit:
