in the full and just sum of Seven Hundred Dollars (\$700.00)
(\$700.00) Dollars monthly with the right to anticipate
the principal or any part thereof at any time,

Paid in full and due
with interest thereon from date at the rate of 6 1/2 per centum per annum, to be computed and paid

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

all that certain piece, parcel or lot of land situate
lying and being in Greenville Township, Greenville County,
State of South Carolina, on the west side of McDaniel
Avenue, and being known and designated as Lot no.
6 on plat of the property of the Estate of T. J. Donaldson
Sr., made by C. M. Furman, Eng., June 1927 said plat
being recorded in the R. M. C. Office for Greenville County
in Plat Book "B" at page 157 and having, according to
said plat, the following metes and bounds, to-wit:-

Beginning at an iron pin on the west side of McDaniel
Avenue at the northwest corner of McDaniel and an un-
named street and running thence N. 9 E. 75 feet along the
west side of McDaniel Avenue to an iron pin, joint
corner of Lots nos. 5 and 6; thence N. 81 1/2 W. 160 feet along
the joint line of Lots nos. 5 and 6 to an iron pin in the
east side of Crescent Court, joint rear corner of Lots nos.
5 and 6; thence along the east side of Crescent Court S. 9
W. 75 feet to an iron pin in the northeast corner of Crescent
Court and unnamed street; thence along the north side of
said unnamed street S. 81 E. 160 feet to the point of
beginning.
