~~thereafter until paid in full, with privilege of making larger~~
~~payments at any time. Note well and truly made~~
with interest thereon from *Sep 1 1934* at the rate of 6 per cent. per annum to be
computed and paid *every month* until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of

and County aforesaid, about three miles Northwest of
the City of Greenville, and being lot no. 97 of a plat made
by Dalton and Neves, September 1925, and recorded in
R.M.L. Office for Greenville County Plat Book 1s. at page
112, and having the following metes and bounds as
shown by said plat:
