WHEREAS, I, Mamie E. Transmire, the said Mamie E. Transmire, in and by I am certain promise my note, in writing, of even date with these presents, to the City View Water and Sewer Commission, Greenville, S.C. well and truly indebted to the full and just sum of Five Thousand (\$500.00) Dollars, to be paid as follows: \$100.00 on November 1st, 1935; \$100.00 on November 1st, 1938. \$100.00 on November 1st, 1936; \$100.00 on November 1st, 1939. \$100.00 on November 1st, 1937; with interest thereon, from date November 1st, 1935, at the rate of 6 per cent. per annum to be computed and paid quarterly until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent.

besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto had, will more fully appear.

NOW, KNOW ALL MEN BY THESE PRESENTS, that I, Mamie E. Transmire, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said City View Water and Sewer Commission, Greenville, S.C. according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to Mamie E. Transmire, in hand well and truly paid by the said City View Water and Sewer Commission, its successors

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said City View Water and Sewer Commission, its successors

All that piece, parcel or lot of land situate South of Hampton Avenue Extension near the city of Greenville, in said County and State and more particularly described as follows:

Beginning at a point west of the Bramlett Road, which point is in the line running N. 81.10 W. as shown by plat recorded Plat Book A, page 217, and which point is approximately 135 feet from the west line of said Bramlett Road and is in the center of a short 30 foot wide unnamed street which runs N. 0. 25 E; thence taking said point as a starting point the line runs along another unnamed street N. 81.10 W. 159.5 feet; thence N. 10.45 W. 65 feet; thence S. 80.15 E. 159.4 feet; thence S. 9.55 W. 65 feet to the beginning corner, together with the right to the joint use of said 30 foot wide unnamed street and a right to the joint use of an alley 10 feet wide running from said unnamed street, also the right to the joint use of the 30 foot alley running into this property from Bramlett Road, on which is located four negro dwelling houses.
