All that certain piece, parcel, or lot of land in Greenville County, Greenville Township, State of South Carolina, on the South side of Arlington Avenue, at the corner of lot formerly owned by Emma L. Butler, which point is 90 feet from Anderson Street, more or less, and running thence with Arlington Avenue in an Easterly direction 52 1/2 feet to stake on corner of property now or formerly owned by Mrs. W. F. Martin; thence with Martin line in a Southerly direction 68 1/2 feet to stake; thence in a Westerly direction 59.4 feet to stake on corner of Butler lot; thence with said line in a Northerly direction 69.7 feet to the beginning.
