WHEREAS, *I*, the said *Mozell Groce*, in and by *Dray* certain *Provisional* note in writing, of even date with these presents, *am* well and truly indebted to

Curtis H. Fowler

in the full and just sum of *One Thousand*

Dollars, to be paid One year after date

with interest thereon, from *Augt 1st* at the rate of *7* per cent. per annum to be computed and paid *Augt 1st*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount so delayed by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

Ten Per Cent.

besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being therunto had, will more fully appear.

NOW, KNOW ALL MEN, That *I*, the said *Mozell Groce*,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Curtis H. Fowler*

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to

in hand well and truly paid by the said *Curtis H. Fowler*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said *Curtis H. Fowler, his heirs and assigns*

All that certain piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina on Queen Street and having the following Metes and Bounds, according to plat made by W. D. Neves, Engineer, Dec. 18, 1913, to wit:

Beginning at a corner of lot of Davis on Queen St. and running thence N. 54° 30' W. 141.5 feet along the line of said Davis lot to an iron pin on line of Scott Estate; thence N. 36° 30' E. 92.3 feet along line of Scott Estate to iron pin at corner of lot formerly owned by Robert M. Kinney; thence S. 54° 30' E. 141.3 feet along line of Robert M. Kinney lot to corner on Queen Street; thence S. 36° 30' W. 92.3 feet along said Queen Street to the beginning corner.

This being the same lot of land conveyed to Ella C. Barr by J. C. Harper by deed dated the 10th day of December 1920 and recorded in R. M. C. Office for said County and State in Vol. 58, page 333.

The above described lot the same conveyed to me by American Building and Loan Association by deed dated November 8, 1934, Deed not yet recorded.
