WHEREAS, I, the said J. W. Parkham, in and by a certain note, in writing, of even date with these presents, am well and truly indebted to H. P. and L. M. McFee, Trustees, in the full and just sum of Seven Thousand Dollars, Dollars, to be paid one year from the date of this note, 1936, with interest thereon, from Oct. 22, 1934, at the rate of 7 per cent. per annum to be computed and paid semi-annually, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 10%.

besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); and by the said note, reference being thereunto had, will more fully appear.

P. and L. M. McFee, Trustees,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said H. P. and L. M. McFee, Trustees,

All that certain piece, parcel or tract of land in Chick Spring Township, Greenville County, State of South Carolina, on the Furman Hall Road, and being a portion of Tract no 4 of the property of J. C. Hall as shown on plat thereof made by R. E. Dalton Dec 1916, and having the following metes and bounds, to wit:

Beginning at an iron pin (corner lot of Ella Francis) in line of lot of E. B. Foister, thence along the line of lot of E. B. Foister S. 53-40 E. 231 feet to an iron pin at rear corner of E. B. Foister lot, thence N. 6-30 E. 383 feet to a stone, thence N. 53-0 W. 145 feet to an iron pin corner lot of J. W. and B. L. Parkham, thence S. 28-15 W. 80 feet to an iron pin corner lot of J. W. Parkham (in line of lot of Estelle Parkham) thence S. 53-40 E. 55 feet to an iron pin rear corner lot of Estelle Parkham, thence S. 28-15 W. 250 feet along the rear line of lots of Estelle Parkham and Ella Francis to the beginning corner.
