WHEREAS, I, the said D. L. Sudduth, in and by my certain person upon my note in writing, of even date with these presents, am well and truly indebted to

J. Rolfe Babb, Attorney in the full and just sum of Seven hundred Fifty Dollars (\$750.00) Dollars, to be paid one year after date.

with interest thereon, from the date of note at the rate of 7% per cent. per annum to be computed and paid annually, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10% besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

Rolfe Babb, Attorney at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said J. Rolfe Babb, Attorney, his successors and assigns, forever.

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, South Carolina in the Town of Greer, and having the following bounds to wit: Beginning at the curb at the intersection of Merchant and Albert Streets, and runs thence south with Albert Street, 116 feet; thence East, 108 feet to G. A. Slack's line; thence North with G. A. Slack's line 102 feet to Merchant Street; thence west with Merchant Street 113 feet to the Beginning corner, this being a part of the same land conveyed to me by J. J. Glasgow, by deed dated December 11, 1914.

There being located on the above described lot my residence, an eight room house and a wooden store building. This being a first lien over the above described property, there being no other liens or encumbrances on the same.
