computed and paid semi-annually

principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of reasonable amount

besides all costs and expenses of collection, to be
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,

All that certain piece, parcel or lot of land,
situate, lying and being in Greenville Township,
in the County of Greenville and State of South
Carolina, about three (3) miles from the City of
Greenville, fronting on the eastern side of the Paris
Mountain Road, or New Greenville-Asheville Highway,
and having the following metes and bounds
to wit:

Beginning at an iron pin on the Eastern side
of the New Greenville-Asheville Highway, said point
being the northwestern corner of the lot owned by
Mr. Reid Hayes and also in the line of the lot owned
by G. H. Neal, and running thence with the line of
the lot in an easterly direction 354.4 feet to an
iron pin on the western side of Cherrydale Drive,
thence with the western side of Cherrydale Drive,
S. 4.30 E. 160 feet to a pin, thence in a westerly
