note in writing, of even date with these presents, are well and truly indebted to American Building and Loan Association in the full and just sum of One Thousand One Hundred Eighty and no/100 Dollars (\$1,180.00) to be paid in installments of Thirteen and 50/100 Dollars, to be paid per month, the same payable on the first day of each and every calendar month thereafter until both interest and principal are paid in full, said monthly installments to be applied first to payment of interest, consecutive monthly on the unpaid balance, and then to payment of principal, at the rate of 7 per cent. per annum, to be computed and paid monthly, all to run until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note or the mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including \$10.00 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.
