in the full and just sum of Eight hundred and fifty (\$850) Dollars,

Dollars, to be paid one year from date

with interest thereon from date at the rate of seven per cent. per annum, to be computed and paid annually from date

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness and to be secured under this mortgage as a part of said debt.

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said G H. Lynn his heirs and assigns,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, O'Neal Township on the west side of the Buncombe Road, adjoining lands of Fred Andrea, Louis Sherfesee and part of the H. D. Lynn Estate, and being a part of the same tract of land conveyed to H. D. Lynn by Howard Caldwell on December 6th, 1919, and recorded in Book 57, page 222, and described as follows: Beginning at an iron pin on the Fred Andrea line, and run thence with said line N. 68-20 E. 678 feet to an iron pin in the center of the Buncombe road, thence with the said road N 29 W 200 feet to bend, thence N 24-10 W 300 feet to a bend; thence N 20 W 47 feet to an iron pin in center of said road, Louis Sherfesee's corner; thence with said Sherfesee line S 68-20 W 1083 feet to an iron pin; thence S. 30-50 E 100 feet to an iron pin in open field; thence N 83-45 E 377 feet to an iron pin; thence S 30-50 E 356 feet to the beginning corner, and containing ten (10) acres, more or less.
