All that certain piece, parcel or tract of land, lying, being and situated in the County of Greenville State aforesaid and in Fairview Township, containing 30.6 acre, more or less, with the following metes and bounds, to-wit: Beginning at a corner on Road, 2111 Garrett property, and running thence S. 87 E. 24.60 to iron pin; thence S. 66 E. 3.75 to stone, thence S. 47 E. 8.33 to a stone; thence S. 48 1/2 E. 11.80 to stone, thence N. 61 3/4 W. 29.70 to stone in road; thence along said road N. 20 E. 5.17 to the beginning corner, and being the same tract of land conveyed to me by deed of A.
