successive months thereafter until full payment to include principal and interest on said mortgage, and I hereby do anticipate payment in cash or by check or in any other way and I do not intend to pay said note.

with interest thereon from June 6, 1938 at the rate of 6 per cent. per annum, to be computed and paid until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 10% besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

Heirs and Assigns, forever, all and singular that certain piece, parcel, slots or tract of land situate, lying and being in Greenville County, State aforesaid,

any part of the same to be known and designated as Tracts nos. 33, 34, 35, 36, 37 and 38, as shown on plat of property of C. S. and St. S. Cunningham, made June 1, 1914, recorded in the G. M. C. Index for Greenville County in Book "4" at pages 267-269, containing in the aggregate 10.72 acres, and some described together, having the following metes and boundaries, to wit:
