All that certain piece, parcel or lot of land, with the inprovements thereon, or to be erected thereon, situate, lying and being on the southern side of and known as No. 704 East Washington Street, in the City of Greenville, in Greenville Township, in the County of Greenville, in the State of South Carolina; being shown and delineated as Lot No. 4 of Block 3 as shown on plat of the Boyce property made by A. W. Edens, January 30, 1901, recorded in the R. M. C. Office for Greenville County in Book of Deeds "ZZ", at Page 935; said premises having the following metes and bounds, to wit: beginning at an iron pin on the southern side of East Washington Street, at a point 409.2 feet in a westerly direction from the intersection of East Washington Street with East McBee Avenue, and running thence S. 32 W. 181 feet to an iron pin in line of property of Steel Manufacturing Company; thence with the line of said property N. 72-15 W. 61 feet to an iron pin.corner of Lot No. 3; thence with the line of said lot, N. 28-30 E. 180 feet to an iron pin on the southern side of East Washington Street: thence with the southern side of East Washington Street S. 71-30 E. 70 feet to the beginning corner; bounded on the north by East Washington Street, on the east by lot now or formerly owned by Mrs. Bessie Norris, on the south by property now or formerly owned by Steel Heddle Manufacturing Company, and on the west by lot now or formerly owned by W. AND IT IS AGREED, by and between the said parties, that all plumbing, heating and lighting fixtures and appurtenances, and all such other goods and effects as are ever furnished by a landlord in letting any unfurnished building, which are or shall be attached to the building covered by these presents, by nails, screws, bolts, pipe connections, masonry or in any manner, are and shall be deemed to be fixtures and an accession to the freehold and a part of the realty as between the parties hereto, their heirs, executors, administrators, successors and assigns and all persons claiming by, through, or under them, and shall be deemed to be part of the security for the indebtedness, herein mentioned and to be covered by this mortgage.

TO HAVE AND TO HOLD all and singualr the said premises unto the said mortgagee, its successors and assigns, forever. And the mortgagor does hereby bind himself, his heirs, executors, administrators and assigns, to warrant and forever defend, all and singular, the said premises unto the mortgagee, its successors and assigns, from and against the mortgagor, his heirs, executors, administrators and assings, and all other persons whomsoever, lawfully claiming, or to claim, the same or any part thereof.
