TO ALL WHOM THESE PRESENTS MAY CONCERN: JOROTHY WEITH HUNTEN, of Greenville, S. C., hereinafter called the Mortgagor, send (s) greetings:

WHEREAS, the Mortgagor and Nick Hunter, are well and truly indebted unto Southeastern LIFE INSURANCE COMPANY, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note, of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of FORTY-FOUR HUNDRED AND NO/100 Dollars (\$44,400.00), with interest from date at the rate of five per centum (5%) per annum until paid, said principal and interest being payable at the office of SOUTHEASTERN LIFE INSURANCE COMPANY in Greenville, S. C. or at such other place as the holder of the note may designate in writing, in monthly installments of Therefore as the holder of the note may designate in first day of July, 1978, and on the first day of each month thereof ter until the principal and interest are fully paid, except that the final payment of principal and interest, it not sooner paid, shall be due and payable on the first day of June, 1958.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagor, and also in consideration of the farther sum of three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagor and Soffere the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and release unto the Mortgagoe, its successors and assigns, the following-described real estate situated in the county of Greenville, State of South Carolina:

All that certain pièce, parcel or lot of land, near the City of premville, County of Greenville, State of South Carolina, on the North side of Ashley Avenue, being known and designated as Lot No. 3, as shown on a plat of property of M. L. Gassaway, made by Darton & Neves, Engineers, June, 1928, which plat is recorded in the R. M. C. Offsice for Greenville County in Plat Book "H" at page 73, and having, according to said plat, and a more recent survey made by R. E. Dalton, Engineer, June 1st, 1938, entitled "Property of Porothy Keith Hunter", the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the North side of Ashley Avenue, joint corner of lots Nos. 3 and 4, which iron pin is 513.3 feet West of the Northwest intersection of Ashley Avenue and North Main Street Extension, and running thence along the joint line of said lots N. 24-38 E. 158.5 feet to an iron pin, joint rear corner of lots Nos. 3 and 4; thence along line of property now or formerly of L. 0. Patterson, N. 79-25 W. 61.85 feet to an iron pin, joint rear corner of lots Nos. 2 and 3; thence along the joint line of said lots S. 24-38 W. 143.7 feet to an iron pin on the North side of Ashley Avenue; thence along the North side of Ashley Avenue S. 65-30 E. 60 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees, as follows:

l. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment; and, provided, further, that in the event the debt is paid in full prior to maturity and at that time it is insured under the provisions of the National Housing Act, he will pay to the Mortgagee an insurance premium charge of one per centum (1%) of the original principal amount thereof, except that in no event shall the adjusted premium exceed the aggregate amount of premium charges which would have been payable if the mortgage had continued to be insured until maturity;
