M. Cannon by J. L. Drake, by deed dated Dec. 3, 1932, recorded in the R. M. C. office for Greenville County in Deed Book 114, page 566, and conveyed to Simmons Realty Company by Mertie N. Cannon, et al., by deed recorded in the R. M. C. office for Greenville County in Vol. 182, page 21.

"All that certain piece, parcel or lot of land situate, lying and being about 22 miles from the Greenville County Courthouse, east of the Lauren's Road, in Greenville County, known and designated as Lot No. 111, on plat of East Lynne Addition South Carolina, and in butler Township, and having, according to said plat, which is recorded in the R. M. C. office for Greenville County, S. C., in Plat Book H, page 220 the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwest side of Sycamore Drive, at joint corner of Lots 110 and 111; thence with the joint line of said lots, S. 28-35 W. 202.7 feet to an iron pin at rear corner of said lots; thence S. 64-41 E. 10 feet to an iron pin; thence S. 63-51 E. 40 feet to an iron pin at rear corner of lots 111 and 112; thence with joint line of said last mentioned lots, N. 28-35 E. 200.4 feet to an iron pin on the southeast side of Sycamore Drive; thence along said Sycamore Drive, N. 61-10 W. 50 feet to the beginning corner, being the same lot conveyed to Simmons Realty Company by Laurens Road Development Company by deed dated May 29, 1936 and recorded in the R.
