Harris (also known as J. D. Harris)-to The Federal Land Bank of Columbia, securing the payment of the principal sum of Ten Thousand (\$10,000.00) Dollars, dated the 7th day of November 1933, and recorded in the public records of Greenville County, State of South Carolina, in Mortgage Book 249, at page 1, the following described property, to-wit:

That certain tract or parcel of land containing One Hundred Fourteen and 25/100 (114.25) acres, more or less, in Grove Township, Greenville County, South Carolina, bounded, now or formerly on the north by other lands of John D. Harris; on the east by lands of H. K. Park; on the south by lands of R. I. Woodside and G. A. Sloan and on the west by lands of Ayers and the Griffin estate, and being more particularly described as Tracts 15 and 16 on a plat of the John D. Harris lands made by William A. Hudson, Surveyor, dated October 21, 1891, on file with The Federal Land Bank of Columbia as follows:
