Whereas, I the said Frances E. Wheeler  
in and by my certain promissory note in writing, of even date with these presents, am  
well and truly indebted to W. C. Henson

in the full and just sum of Four Hundred Fifty  
(\$ 450.00) Dollars to be paid one year from date

with interest thereon from date at the rate of 7 per centum per annum, to be computed and paid annually
