

BEGINNING at an iron pin on the North side of Ninth Street 50' West of the intersection of said Street and Whitmire Street and running thence in a Northerly direction 150' more or less, to an iron pin in line of lot #3; thence in a Westerly direction 50', more or less, to an iron pin in line of lot #19; thence in a Southerly direction 154; more or less, to an iron pin on the North side of Ninth Street; thence in an Easterly direction with said Street 50' to the beginning corner.

Lot No. 17 of Block A, as shown on said plat, and being more particularly described as follows: BEGINNING at an iron pin on the Northsside of Ninth Street 150' West of the intersection of said Street and Whitmire Street, and running thence in a Northerly direction 154' more or less, to an iron pin in line of lot #7; thence along line of lot #7 in a Westerly direction 50' to an iron pin >9 in line of the Southern Weaving Company property; thence with line of said property in a Southerly direction 154, more or less, to an iron pin in the North side of Ninth Street; thence along said Street in an Easterly direction 50' to the beginning corner.
