

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, D. Minnie Brewer, of Greenville, S. C. SEND GREETINGS:

WHEREAS I, the said D. Minnie Brewer

in and by my certain promissory note, in writing, of even date, with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

ONE THOUSAND, FIVE HUNDRED & NO/100

(\$1,500.00) Dollars, with interest at the rate of (6%) per centum per annum to be repaid in installments of

FIFTEEN AND NO/100

(\$ 15.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or future to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said D. Minnie Brewer

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Butler Township, and being known and designated as Lot No. 10, of Block E, in a subdivision known as Carolina Court, as shown by plat thereof, recorded in the R. M. C. office for Greenville County in Plat Book "F", at page 96, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the west side of Montevista avenue and on the north side of Wickliffe Street, and running thence along the line of said Montevista Avenue, N. 23-55 E. 293.2 feet to an iron pin, in line of C. & W. C. Railroad right-of-way; thence along the line of said right-of-way, N. 72-0 W. 60 feet to an iron pin, rear corner of Lots 9 and 10; thence along the joint line of said Lots 9 and 10, S. 25-45 W. 273.4 feet to an iron pin on the north side of Wickliffe Street; thence along the line of said Wickliffe Street, S. 54-55 E. 70 feet to the beginning corner. Being the same lot conveyed to me by J. B. Ricketts, as Trustee, by deed dated November 14th, 1939, and recorded in the R. M. C. Office for Greenville County in Vol. 216, at page 329."
