TO ALL WHOM THESE PRESENTS MAY CONCERN:

Roy D. Williams of Greenville, S. C., hereinafter called the Mortgager, send(s) greetings:
WHEREAS, the Mortgagor is well and truly indebted unto Bank of Greenwood, Greenwood, S. C.,
a corporation organized and existing under the laws of South Carolina, hereinafter called the
Mortgagee, as evidenced by a certain promissory note of even date hereinith, the terms of which are
incorporated herein by reference, in the principal sum of FIFTEEN HUNDRED AND NO/100 Dollars
(\$1,500.00), with interest from date at the rate of four and one half per centum (4½%) per annum
on the unpaid balance until paid, principal and interest being payable at the affice of Bank of
Greenwood, in or at such other place as the holder hereof, may designate in writing, in (morthly)
installments of Fifteen and 56/100 Dollars (\$15.56), commencing on the first day of June, 1940,
and a like amount on the first day of each month, in each year the reafter until the principal and
interest are fully paid, execpt that the final payment of principal and interest, it not pooner
paid, shall be due and payable on the first day of May, 1950.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, pargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or tract of Hand in the County of Greenville, State of South Carolina, on the South side of Settlement Road, containing 27/1 acres, more or less, and having the following metes and bounds, according to a plat of the property of Roy D. Williams made by Dalton & Neves, Ingineers, Movember, 1st, 1959:-

BEGINATING at an iron pin on the Settlement Road, corner of Case land, and running thence with the Settlement Road S. 61-10 W. 734 feet to an iron pin in stone pile, corner of land now or formerly belonging to W. F. Convers; thence with said convers line, S. 18-50 E. 1,630 feet to an iron pin in stone, corner of Styles land; thence with Styles line N. 63-05 E. 439 feet to center of creek; thence N. 62-50 E. 294 feet to an iron pin, commer of land of Julia Litchen; thence with line of Kitchen and Case N. 18-50 W. 1,860 feet to the beginning corner; using the same lot of land conveyed to the mortgagor herein by E. F. Hipp by deed dated hovember 15th, 1939, and recorded in the R. M. C. Office for Greenville County in Deed Foot 215 at 1926 316.

Together with all and singular the rights, members, heredisaments, and appartenances to the same belonging or in any way incident or appertaining, and will be the rents, issues, and profits which may arise or be had therefrom and including all heating plumbing and lighting fixtures and equipments now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premsies anto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

- 1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole or in an amount equal to one or more (annual) (semi-annual) (monthly) payments on principal that are next due, on any periodic payment date; provided, however, that written notice of intention to exercise such privilege is given at least thirty (30) days prior to prepayment. In the event this debt is paid in full prior to maturity and while it is insured under the provisions of the National Housing Act. all parties liable for the payment of same, whether principal surety, guarantor, or endorsed, agree to be jointly and severally bound to pay to the holder hereof and adjusted premium charge of one per centum (1%) of the original principal amount of the debt evidenced thereby, provided that in no event shall the adjusted premium charge exceed the aggregate amount of premium charges which would have been payable if the mortgage had continued to be insured until maturity; such payment to be applied by the holder hereof upon its obligation to the Federal Housing Administrator on account of mortgage insurance; provided, however, that the liability of any party herein to pay the above-mentioned adjusted premium charge shall be, in any event, subject to the exceptions contained in the Regulations of the Federal Housing Administration in force on the date this instrument is executed.
- 2. That, together, with, and in addition to the (annual) (semiOannual) (monthly) payments of principal and interest payable under the terms of the note seucred hereby, he will pay to the
