Fowler to The Federal Land Bank of Columbia, securing the payment of the principal sum of Twelve Hundred (\$1200.00) Dollars, dated the 13 day of January, 1934, and recorded in the public records for Greenville County, State of South Carolina, in Mortgage Book 249, at page 54, the property hereinafter described; and that for and in consideration of the sum of One (\$1.00) Dollars, receipt whereof is hereby acknowledged, Federal Farm Mortgage Corporation, the owner and holder of the security instrument hereinafter referred to and of the note thereby secured pursuant to the Act of Congress known as Federal Farm Mortgage Corporation Act. (Sec. 1020b, Title 12, U. S. C.), by and through the Federal Land Bank of Columbia, as its Agent and Attorney in fact pursuant to the Act of Congress known as Farm Credit Act of 1935 (Sec. 1016h, Title 12, U. S. C.) does, subject to the conditions hereinafter stated, hereby release from the lien of that certain security instrument, executed and delivered by Daniel W. Fowler, the Land Bank Commissioner, securing the payment of the principal sum of Thirteen Hundred Dollars (\$1300.00), dated the 13 day of January, 1934, and recorded in the public-records for Greenville County, State of South Carolina, in Mortgage Book 247, at page 154 the property hereinafter described, to-wit:

One and 9/100 (1.09) acres, more or less, lying south of the Brockman Bridge and described on a plat of survey thereof made by W. J.
