Since the acquistion of this property by R. S. Eassy, the said property has been redivided in lots No. 21A, 22A, 23A, 24A, 25A, 26A, 27A, 28A, and 29A.

It is expressly understood between the parties to this mortgage that the mortgage shall cover lots No. 21A, 25A, 28A, and 29A. Lots No. 25A, 28 A, and 29A shall be released at any time upon payment of \$100.00 each.
