Fisher of the County of Greenville, State of South Carolina, hereinafter called Mortgagor, has become justly indebted to the United States of America, acting by and through the Secretary of Agriculture, pursuant to the provisions of Title I of the Bankhead-Tones Farm Temant Act, hereinafter called Mortgagee, as evidenced by one certain promissory, note, dated the 9th day of April, 1941, for the principal sum of Three Thousand Seven Hundred Thirty & 100 Dollars (\$3,730.00)) with interest at the rate of three percent (3%) per appum, principal and interest payable, and amortized in installments as therein provided, the first installment of one Hundred Sixty one & 36/100 Dollars (\$161.36) being due and collected of the 31st, day of December, 1941, the next sacceeding thirty-eight installments, annually the feafter, and the mortieth installment, either thirty-nine years thereafter, or
