WHEREAS, JESSE M. RAY executed and delivered to The Prudential Ins. Co. of America,
a certain note secured by a mortgage /upon real property situated in Greenville County, South Carolina, dated December 11, 1931,
which said Mortgage was recorded in said County on December 17, 1931, in Book 219, on page 22,
and which said note and Mortgage are now owned and held by The Prudental Insurance Company
of America, and
WHEREAS, the said note has matured, or will mature on December 11, 1941, either in
accordance with its terms or by virtue of the terms of a previous extension, and
WHEREAS, title to the mortgaged premises is now vested in Jesse M. Ray subject to
said Mortgage, and WHEREAS, the said Insurance Company has been requested to extend the time and modify
the terms of payment of the indebtedness represented by the aforesaid note upon the terms herein-
after set forth, which it has agreed to do in consideration of the agreement herein contained
on the part of the signers hereof, which extension and modification shall take effect as of the
dage hereof,
Now, Therefore, the undersigned hereby jointly and severally promise and agree to pay
the principal sum of \$1,650.00 remaining unpaid under said note, as follows: Beginning on the
eleventh day of December, 1943, and on the same day in each succeeding year the reafter the sum
of Fifty Dollars (\$50.00) and the balance of said principal sum payable on the eleventh day of
December, 1951, with interest thereon from December 11, 1941, or until default, at the rate of Five (5%) per cent. per annum, payable annually; and with interest after maturity or after de-
fault in the payment of principal or interest, as set forth in said note, if such interest
rate after default or after maturity be lawful under present statutes; but if not, then at the
maximum rate permissible under such statutes.
Privilege is given to make additional payments on the principal of this indebtedness
in sums of \$100.00 or multiples thereof on any date when interest becomes due and payable;
provided, however, that the amount so paid during amy year ending at an anniversary of the date
from which interest accrues hereunder, added to obligatory principal payments, if any, falling due within such one year period, shall not exceed one-fifth of the principal sum payable under
the terms of this instrument.
And the owner will keep the buildings upon the mortgaged real estate insured in such
forms of insurance as may be required by the Mortgagee in insurance companies and in amount
satisfactory to the Mortgagee, and the policies shall contain all proper clauses for the
protection of the Mortgagee. If the owner shall fail to perform the above agreement, the Mortgage
may declare the Mortgage in default, with the same appropriate penalties as recited in the
Mortgage for other defaults, and may effect said insurance, and all money paid therefor with
interest at the penalty rate recited in said Mortgage shall be secured by and collectible under
And the parties who execute this agreement hereby agree that said Mortgage shall
continue a first lien upon the premises described therein, and further agree to perform each and
every of the terms, covenants, conditions and agreements in said note and Mortgage as herein
modified.
