not to exceed the sum of \$115.12 to be evidenced by the Eighth Note and not to exceed the sum of \$20,000 to be evidenced by a note or notes to be executed by the Cooperative and delivered to the Government, and that such amounts when so advanced, together with interest in respect thereof, will be secured by the Mortgage; and

(c) That the Mortgage provides for the execution by the Cooperative and the delivery to the Government from time to time of additional notes to be secured by the Mortgage to evidence additional loans which may hereafter be contracted to be made by the Government to the Cooperative, the aggregate principal amount of which together with the aggregate principal amount of the Outstanding Notes shall not exceed \$1,500,000, and for the issuance of notes to refend any of the Outstanding Notes or any such additional notes, or in renewal thereof, or in substitution therefor.
