

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Greenville Township, on the western side of Grove Road, near the City of Greenville, being shown as Lot No. 18 of Block M on plat of property of O. P. Mills made by H. Olin Jones in May, 1914, recorded in Plat Book C at Page 176 and described as follows:
