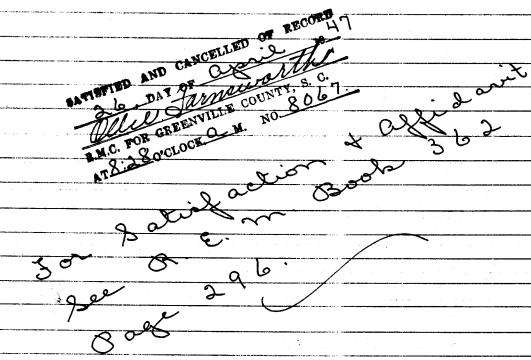

Tract No. 1: Having according to survey made by E. A. Ellis, Surveyor, October 7, 1937, the following metes and bounds:

BEGINNING at an iron pin on the Western side of Parker Road, corner of the property of H.A. Chapman, and running thence with the line of said property, N. 63 W. 195 feet to a pin; thence N. 25-50 E. 40 feet to an iron pin; thence N. $75\frac{1}{4}$ E. 136.5 feet to an iron pin on Parker Road; there with the Western side of Parker Road, S. 10 E. 164 feet to the beginning corner.

Hughes, N. 62 W. 195 feet to an iron pin in line of seit tracts Nos. 4 and 5; thence S. 24 3/4 W. 100 feet to an iron pin; thence S. 80 E. 226.9 feet to an iron pin in the West side of Parker Road; thence along the Western side of Parker Road N.10 W. 36 feet to beginning; being the same property conveyed to the mortgagor by James G.
