MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Marshall L. Cason

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Beatrice Street in the City of Greenville, being shown as Lot No. 3 on plat of property of Eva Jones made by W. J. Riddle in October, 1945, and described as follows:

"BEGINNING at a stake on the Eastern side of Beatrice Street, 240 feet South from Frances Avenue at corner of Lot No. 2, now or formerly owned by Robert A. Junkin, and running thence with the line of said lot, N. 67-48 E. 240.7 feet to a stake, corner of property of George F. Jones; thence with the line of said property, S. 21-55 E. 60 feet to a stake; thence S. 67-48 W. 240.7 feet to a stake on Beatrice Street; thence with the Eastern side of Beatrice Street, N. 21-55 W. 60 feet to the beginning corner."
