

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Western side of Third Street(formerly known as Lindburg Street) at Slater, S. C., being lots Nos. 1 and 2, and the rear portion of lots Nos. 10 and 11 ob Block E., as shown on plat of the Village of S. Slater & Sons, Inc., made by J. E. Sirrine & Company, Engineers, on July 10th 1940, and recorded in the R.M.C. Office for Greenville County in Plat Book "K" at pages 63, 64 and 65, and being more particularly described as follows:

BEGINNING at an iron pin on the West side of Third Street (formerly known as Lindburg Street) joint front corner of lots 2 and 3 of Block E. and running thence with the line of lot No. 3 S. 82-39 W. 124 feet to an iron pin in rear line of lot No. 9; thence with the line of lot No. 9 S. 7-19 E. 60 feet to stake; thence with line of lot No. 9 S. 82-41 W. 12 feet to an iron pin; thence along a new line through lot No. 10 S. 7-19 F. 70 feet to an iron pin in the joint line of lots 10 and 11; thence along a new line across lot No. 11 S. 12-15 E. 70.3 feet to an iron pin in joint line of lots 11 and 12; thence with the line of lot No. 12 N. 82-41 E. 6 feet to an iron pin on the Northwest side of Third Street (formerly Lindburg Street); thence with Third Street N. 31-41 E. 197.07 feet to bend in said street; thence continuing with Third Street N. 7-21 W. 46.95 feet to point of beginning.
