And the said Mortgagor hereby binds himself and his successors, heirs, executors, administrators and assigns to warrant and forever defend all and singualr the said premises unto the said Mortgagee, its successors and assigns, from and against the Mortgagor and his successors, heirs and assigns and against every person, whomsoever, lawfully claiming or to claim the same or any part thereof.
