MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I , Marion Young

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being the western portion of Lot No. 64 on plat of Pride and Patton Land Company, recorded in Plat Book E at Page 249; and described as follows according to said plat
