NOW, KNOW ALL MEN, That I, the said Ruby McDonald Henry in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the term of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sailing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bangained, sold and released, and by these presents degrant, bargain, sell and release upto the said 0. L. Jones

And I do hereby bind myself, my Heirs, Executors and Administrators towarrant and forever defend all and singular the said premises unto the said mortgagee, his Heirs and Assigns, from and amainst me, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.

And I, the said mortgagor, agree to insure the house and buildings on said land for not less than Two Thousand (fire), Two Thousand (windstorm) Dollars, in a company or companies which shall be acceptable to the mortgages, and keep the same insured from loss or damage by fire during the continuation of this mortgage, and make loss under the policy or policies of insurance payable to the mortgages, and that in the event I shall at any time fail to desc, then the said
