LOT NO. 4: BEGINNING at an iron pin on the corner of Lot No. 3, which pin is 7 feet from the South side of Sulphur Springs Road and on edge of a 7 feet strip reserved for a sidewalk and running thence with sidewalk S. 86-36 W. 100 feet to an iron pin, corner of Lot No. 5; thence with line of Lot No. 5, S. 0-06 E. 182.9 feet to iron pin; thence N. 87-15 E. 100 feet to iron pin at the corner of Lot No. 3; thence with line of Lot No. 3, N. 0-06 W. 183.6 feet to the beginning corner;

LOT NO. 5: BEGINNING at iron pin, corner of Lot No. 4, which pin is 7 feet from the South side of Sulphur Springs Road from the edge of a 7 foot strip reserved for a sidewalk; thence along the edge of sidewalk S. 86-36 W. 50 feet to iron pin, corner of Lot No. 6; thence with line of Lot No. 6, S. 0-06 E. 182 feet, more or less to iron pin; thence S. 87-15 E. 50 feet to corner of Lot No. 4; thence with line of Lot No. 4 N. 0-06 W. 182.9 feet to the beginning corner,
