All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Southwest side of Longview Terrace in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 31 on Plat of Forest Heights, made by Dalton & Neves, Engineers, June 1946, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "P", Page 71, and having, according to a recent survey made by A. C. Crouch, Engineer, December 16, 1947, the following metes and bounds, to-wit:
