That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about two miles North from Greer, lying on the East side of the Greer-Landrum Highway and on the North side of the Ballenger Road, being all of tracts Nos. 5, 14, 15 and 16 on a plat of property made for Mrs. Eula A. Mayfield by H. S. Brockman, Surveyor, January 27, 1945, and having the following courses and distances, to wit:-

BEGINNING on an iron pin in the intersection of the Greer-Landrum Highway with the Ballenger Road, and runs thence with the Greer-Landrum Highway N 23-45 W 323 feet, more or less, to an iron pin, corner of Tract #6 on said plat; thence with the line of this tract N 67 E 409.5 feet to an iron pin on line of Tract #15, thence N 16-45 W 441.5 feet to an iron pin, the southwestern corner of Tract #17, thence with line of Tract #17 N 76-20 E 404 feet to a stake in the center of the CC Camp road; thence S 15-15 E 287.5 feet to a stake; thence continuing with center of said road S 10-40 W 372 feet to a stake in intersection of the CC Camp road with the Ballenger Road; thence with the center of the Ballenger Road as follows: S 71-55 W 125 feet, S 63-13 W 100 feet, S 56-27 W 100 feet, and S 51-07 W 500 feet to the beginning corner, containing 7.62 Acres being the same tracts of land conveyed to me by Mrs. Eula A.
